Jewish Book Annual. N.Y.: JWB Book Council, 1942 – .

Includes listings of new American Jewish literature as well as pertinent articles.

Liptzin, Sol. *The Jew in American Literature*. N.Y.: Block, 1966.

Covers the colonial era to the early 1960s. Includes good bibliographies.

Madison, Charles A. Jewish Publishing in America: The Impact of Jewish Writing on American Culture. N.Y.: Sanhedrin/Hebrew Pub. Co., 1976.

Includes chapters on major publishers of American Jewish literature, Yiddish literature and writers, and 'Anglo-Jewish' periodicals. Concludes with 'Jewish Influence in American Publishing.'

Malin, Irving, ed. Contemporary American-Jewish Literature: Critical Essays. Bloomington, IN: Indiana Univ., 1973.

Includes a bibliography of American-Jewish literary criticism.

Mersand, Joseph. *Traditions in American Literature: A Study of Jewish Characters and Authors*. Port Washington, N.Y.: Kennikat Press, 1939, reissued 1968.

Includes essays on Jewish American novelists, poets, and dramatists, as well as bibliographies.

Walden, Daniel, ed. Studies in American Jewish Literature. Albany, N.Y.: SUNY, 1975– . Annual.

#### **Authors**

Look under individual authors' names in the subject catalog to locate biographical and bibliographical information, and criticism of their work. Examples:

MLA International Bibliography of Books and Articles on the Modern Languages and Literatures, 1919–

Use the American literature section.

Note the chronological subdivisions. Since 1981, a subject index volume is also available.

# Register of Judaica Bibliographies in Progress Barry Walfish

University of Toronto Toronto, Canada

It has been proposed that a regular column be set up in *Judaica Librarianship* to register work in progress in Judaica bibliography. This would help to eliminate unnecessary duplication and might encourage cooperation on specific projects. Anyone working on a project in Judaica bibliography is encouraged to send information about it to Barry Walfish, University of Toronto Library, Toronto, Canada, M5S 1A5. The following information should be included:

- 1. Precise topic of the bibliography.
- 2. Its scope: type of material included (popular or scholarly, primary or secondary, etc.); time span covered; languages covered, etc.
- 3. Plans for publication. Include only if contract signed with publisher (for monographs) or bibliography accepted by a journal. Include projected date of publication if known.
- 4. Plans for updating bibliography.
- 5. Name and institutional affiliation of compiler.

As examples, the following are projects that the editor of this column is currently engaged in:

- A. 1. A Bibliography of the Karaites
  - 2. To include all primary material in all languages both in print and in manuscript that is accessible to Western scholars and as much Soviet material that is possible. All secondary material of a scholarly and popular nature will also be included except newspaper and encyclopedia articles.
  - 3. Publication arrangements not confirmed.
  - 4. Bibliography will be updated.
  - 5. Barry Walfish, University of Toronto Library.
- B. 1. A Bibliography of Medieval Jewish Biblical Exegesis
  - 2. To include all Jewish commentaries on the Bible, in print or in manuscript, written in the Middle Ages (900–1500). Principal languages are Hebrew and Judeo-Arabic. Only secondary material dealing with specific commentaries and their identification will be included.
  - 3. Publication arrangements not confirmed.
  - 4. Bibliography will be updated.
